Election of Officers & Committee Members and Changes to Constitution

The terms of office of Jo McCann, Brenda Murray, Charlie Collier, Netta Dixon & Mary Harrison all come to an end at the forthcoming AGM. Although they have not yet been asked to do so, it is assumed that they will all be prepared to stand for election for a further term, and that Jo will be prepared to continue as Admin Secretary. On this assumption, your Committee has pleasure in recommending them for re-election.

While those able to attend our meetings will already be aware of this, members are informed that, because of pressure of his professional career, Jon Murden, who took over as Membership Secretary at the last AGM, found it necessary to resign from that post and the Committee in January. His decision was received with much regret by the Committee, not only because he reduced its average age quite considerably (!), but because of the useful link that he provided with the National Museums in Liverpool. We would like publicly to thank him for his input into the Society's affairs and wish him well in his onerous task in the provision of the successor to the city's much-missed Museum of Liverpool Life.

Mike Brian, the previous Membership Secretary, has, *pro tem*, assumed those duties in addition to those of Treasurer, and has indicated that, if no volunteer is forthcoming, he is prepared to continue to carry out both tasks in tandem. However, as this is not strictly in accordance with the Society's present Constitution, he considers that formal approval of such an arrangement should be requested from and given by the forthcoming AGM, that the Constitution should be changed to accommodate this, and that approval then be sought from the Charity Commission. A copy of the Constitution, so amended at para [6.3], and incorporating a number of minor clarificatory or stylistic amendments at paragraphs [1.2], [3.1.2], [4.3], [5.1], [6], [7.1],[8.4 & 5], [9.1], [10.1] and [13.3], for which approval will also be sought at the AGM, is enclosed

Jon's departure creates a sixth vacancy on the LHS Committee, and Rob Ainsworth has indicated a willingness to join the Committee and assist with the Newsletter and Website. Acceptance of his offer is also recommended

In making these recommendations, the Committee would again remind Members of their right, under para 7.2 of the Society's Constitution, to nominate other candidates for election to these six positions.
